**ARTICLES**

2. Shall the School District raise and appropriate as an operating budget, not including appropriations by special warrant articles and other appropriations voted separately, the amounts set forth on the budget posted with the warrant or as amended by vote of the first session, for the purposes set forth therein, totaling Eighty-Five Million, Five Hundred Seventy Thousand, Four Hundred Fifteen Dollars (\$85,570,415)? Should this article be defeated, the 2017-2018 operating budget shall be Eighty-Six Million, Fifty-Two Thousand, Four Hundred Eighty-Eight Dollars (\$86,052,488), which is the same as last year with certain adjustments required by previous action of the School District or by law; or the governing body may hold one special meeting, in accordance with RSA 40:13, X, and XVI, to take up the issue of a revised operating budget only. **(Recommended by the Derry School Board)**

3. Shall the School District approve the cost items included in the collective bargaining agreement reached between the Derry School Board and the Derry Education Association that calls for the following increases in salaries and benefits at current staffing levels in the prior fiscal year:

and further to raise and appropriate the sum of Four Hundred Eighty-Seven Thousand, Three Hundred Sixty-Two Dollars (\$487,362) for the upcoming fiscal year (2017-2018), such sum representing the additional costs attributable to the increase in salaries and benefits required by the new agreement over those that would be paid at the current staffing levels? **(Recommended by the Derry School Board)**


