Dear Parents/Guardians of Incoming Kindergarten Students (2018-2019),

It is registration time for next fall's incoming kindergarten students. Enclosed is a brochure that explains our kindergarten registration process, as well as an application for those of you who may be interested in registering your child for the full day program.

Registration for the 2018-2019 school year begins on November 1, 2017 through November 30, 2017. Please call your local school to schedule an appointment to complete the registration process. Forms for registration may be found online at [www.sau10.org](http://www.sau10.org) and can be printed and completed prior to your appointment. They are also available at your local school and at the Superintendent's office.

Full-day kindergarten will be determined on a first come, first served basis and requires a deposit at the time of registration. Please call your local school as soon as possible to schedule an appointment to secure your spot in the Derry Cooperative School District. If it is the half-day kindergarten program you are interested in, please call your local school to schedule an appointment. During your appointment, please inform the school secretary if you have a preference for the morning or afternoon session. They will do their best to accommodate your request.

**At the time of your appointment you will need to bring:**

- Your child's birth certificate
- Your child's most recent immunization and physical records
- TWO different proofs of residency (i.e., current tax bill, lease agreement, or a purchase and sale agreement AND a recent utility bill)
- Completed Registration Form, Student Health History (2 pages) and Home Language Survey (all forms are on the Derry School District's website, [www.sau10.org](http://www.sau10.org))
- Custody papers, parenting plan, or other legal documents
- A photo ID for the parent or guardian

Lastly, all students currently enrolled in the DEEP program do not have to re-register and will automatically be enrolled in the half-day program. However, if a parent of a DEEP student would like to enroll in a full-day program, the enclosed application needs to be completed and turned in to your local elementary school along with the deposit.
